(Interim) President Report: Nancy Ellis

- We have re-negotiated the First American Management monthly charge from \$11.00 per lot and \$13.47 per home, down to a flat fee of \$10.00 for each.
- The Board is working with 1st American in looking at the possibility of putting some of the Reserve funds into CDs to earn interest due to current high yield rates.
- We are in the process of obtaining two quotes and information regarding a Reserve Study to better plan for our future expenses with a focus on roads, streetlights and gates.
- Don Plumb is reviewing software availability to update the site map on the FW website.
- The Board will be meeting in March for a strategic planning summit for short term and long-term goals.
- The Homeowner Engagement survey will be going out to all FWHOA residents this spring.
- The HOA's 2022 taxes have been completed at a cost of \$200.00.

Director Update: Zac Garner

Zac presented a program he's worked on with Omar Estrada and Mike Berta to help streamline the ACC approval process. He suggested a vote, but that motion was tabled until the Board has a better understanding after the March Executive Board meeting.
