## **Community Discussion:**

- Concerns over the budget not including enough money next year to fix all streetlights was discussed. Currently, the Board will prioritize current working light repairs with funds from 2024 budget and work towards the addition of adding new hook-ups and lights to the areas on the northside.
- Concerns over the budgeted cost for replacing the landscape lighting around the south gate was discussed. A community member will provide the prior companies contact information for who worked on the lights before, so they can also provide a quote.
- Concerns over the Board not charging enough for dues was brought up.
- Discussions were had about some items of the budget on current payments being actuate. It was discussed that if it hasn't posted or a bill hasn't been received yet we aren't able to post it. We also still have three months till the end of the year. The current items provided are only current through September.

- New application for new home builds was discussed and the changes. Contractors will now need to provide as-builts and proof of completion of construction to received deposit back.
- Money has been budgeted to have covenants revised.
- Drains being run to the roads needs to be addressed and make sure that builders are no longer able to run drainage to the road. 20' back from road.
- A community member brought up they had difficulty entering at the North (back) gate.
